
Coordination Activities

- >21.000 tickets handled in 2008
- 14.000 tickets handled in 2009 so far
- Stable 1 day response time

Registration Services (1)

Maintaining SLAs, with high ticket load

- Reclamation project:
 - Announced IP address space, "pending closure" LIRs
 - Since 2007, 703 non-paying LIRs contacted (phase 2)
 - 82 LIRs re-opened
 - 480 Allocations returned to the RIPE NCC so far (5,036,032 IP addresses)
- Audit activity 40 new LIR Audits started each month

 - New Member Portal




Member Closures

- Why talk about it now?
 - Policy clarification needed (ripe-471)
 - Outdated procedure documentation
 - ripe-301 from 2004, will be updated
 - Important for membership statistics / revenue
 - Sharing experience with closures and reclaiming addresses
 - Interest by Anti-Abuse WG

Closure reasons



- Non payment of membership fees
- Merger/takeover
- Voluntarily upon members request
- Contract issues / New LIR issues / negative audit



"Positive" experience with closures

- Return of IPv4 addresses (Reclamation)
 - Contact registry for return of IPv4 resources
 - If no reply and unannounced reclaim
 - If no reply and announced contact upstreams for contact information
 - If no contact information contact upstreams to stop routing the allocation
- Total IPs reclaimed 5 million (/10, /13, /14)
- Members "repatriated", worth 200 kEUR



Future activities / projects

- Continue current reclamation efforts
- Rewrite ripe-301
 - Separate document for merger/takeover etc.
 - Separate document for closures
 - Clear definition of reasons for closure
- Integrate process of closure and reclamation



Perennial IT Renewal

- Back-Up and Archiving
 - Throwing out tapes in favour of redundant online storage




Asset Management

Information Services Developments

- TTM Partnership with APNIC
 - New node in Pakistan, more to follow
- RIS backend architecture improvements
 - Most queries 10x faster, some up to 35x faster
- New BGP visualisation tool, BGPviz:
 - http://www.ris.ripe.net/bgpviz/
- Netsense
 - Hard at work on a new portal system
 - Combine most useful elements from RIS/TTM etc.
 - More intuitive look and feel soon to come



Science Group

- Making progress on quality and consistency of (mostly historical) registration data
 - Will need to make progress with the few inconsistencies that remain inter-RIR, need support of other RIRs

New Tool Taking Shape

- Working on a new toolset, working name "Rex": (Internet Number) Resource Explainer
 - presents information about specific Internet number resources from
 - registration data, DNS, BGP Routing (RIS)
 - presents all this as it develops over time
 - for any time in the past (have data for this decade or more)
 - version 0.1 covering IPv4 addresses launched in RIPE Labs



External Relations and Communications

- Joint effort with NRO: ICANN, OECD, IGF, ITU, ITU Telecom World
 - Donated sizeable amount of Paul Rendek's time to NRO for PR & Comms efforts
- Secretariat support for ASO (heavy hit on resources)
- IPv6ActNow.org

- Other regional events
 - E.g. various IGF related events
- Strong support for EU IPv6 survey
